**WILBERT REED**

Wilbert Reed, 45 years old, died Monday night, January 12, at his home at Avena after a five-month illness. He was born November 8, 1896, a son of the late James Thomas and Elizabeth Clifford Reed. Mr. Reed is survived by his wife, Mrs. Myrtle Henson Reed, two sisters, Mrs. William Prichard of Rushtown, Ohio, and Mrs. Everett Marshall of Harrison county, and a brother Carl Reed of Friendship, Ohio.
