WIDOW, 70, SUCCUMBS

Mrs. Mary Wieghaus Dies at Covington Hospital; Rites Tuesday

Mrs. Mary Wieghaus, 70, widow of Joseph Weighaus, formerly Covington city jailer, died at St. Elizabeth Hospital, Covington, late Friday. She had lived in Covington until seven years ago, when she went to Madison, Ind., to live with her brother, John Busse.

When she became sick she was taken to the hospital from Madison, where she has been for the past three weeks. Mrs. Weighaus is survived by her brother and one sister, Mrs. Josephine Ringwald, also of Madison, Ind.

Last rites will be held at the funeral home of Hugenberg & Glindmeyer, Covington, Tuesday at 8:30 a. m. Requiem high mass will be intoned at Mother of God Church at 9 a. m. Burial in Mother of God Cemetery.
